Chairman's Circle

Availability: Private companies or firms that support economic development in Missouri, or organizations that maintain an economic development division or department in Missouri, including organizations that cover the entire state.

Term: Annual (MEDC fiscal year)

Investment: \$7,500

Benefits:

- Company logo will be displayed on signage and in printed materials at all MEDC conferences.
